MOTION FOR RESITUTION FINDINGS AND ORDER OF JUDGMENT

GEORGE H. BRAUCHLER, District Attorney in and for the Eighteenth Judicial District, by and through his duly appointed Deputy District Attorney, respectfully requests this Court impose restitution as a provision of the defendant's sentence. As grounds therefore, the People state the following:

1. On July 16, 2015, the defendant was found guilty of 24 counts of Murder in the First Degree, 134 counts of Attempted Murder in the First Degree, 6 counts of Attempted Murder in the Second Degree and Possession of an Explosive or Incendiary Device. The defendant will be sentenced on August 26, 2015.
2. The People are in the process of determining the total amount of restitution and have a current figure of \$ **796,262.00** for payments made on behalf of Victims by Victim Compensation. This is not a final number for either Victim's Compensation or for the losses of the Victims.
3. The People request that restitution be reserved for 70 days pursuant to Section 18-1.3-603(2), C.R.S. so that the People may have time to calculate the additional restitution requested by the Victims and to supplement the additional Victim Compensation payments that may be made to Victims during the next seventy days. Due to the large number of victims and the magnitude of injuries they have suffered the People believe good cause exists to request additional time.
4. The People further request this Court to order the defendant to pay restitution for actual costs of future treatment, as provided for in Section 18-1.3-603(1)(c), C.R.S.

WHEREFORE, the People respectfully request the Court to enter Restitution Findings

and Order of Judgment as a provision of defendant's sentence, reserve additional restitution for 70 days, and that the Mittimus be amended to reflect the Court's Order.

RESTITUTION FINDINGS AND ORDER OF JUDGMENT

Upon consideration of the Motion for Restitution in the above captioned case, the Court being fully advised, **ORDERS:**

That the District Attorney's Motion for Restitution is granted and the Mittimus shall so reflect the amount of \$ 796, 262 in restitution is ordered as a term and condition of defendant's sentence, to be distributed to the victim(s)/agent(s) noted below, and that **JUDGMENT ENTERS** in favor of the People of the State of Colorado and the following judgment creditors as follows:

Victim's Compensation

Interest on the judgment shall run at the rate of twelve percent (12%) per annum, pursuant to Section 18-1.3-603(4)(b)(I), C.R.S.

The defendant is ordered to pay restitution for actual costs of future treatment of victims.

Restitution is reserved for an additional 70 days for additional requests.
