JUDGE SAMOUR REPORTER: MARTIN ALL DAY
DEFENDANT APPEARS IN CUSTODY WITH HIS ATTORNEYS TAMARA BRADY, DAN KING,
REBEKKA HIGGS, KATHERINE SPENGLER, AND KRISTEN NELSON. THE PEOPLE ARE
REPRESENTED BY GEORGE BRAUCHLER, JACOB EDSON, KAREN PEARSON, RICH ORMAN,
LISA TEESCH-MAGUIRE, AND DAN EDWARDS.
THE JURY RETURNS AT 8:30 A.M. AND RESUMES DELIBERATIONS. THE JURY SUBMITS
A NOTE REQUESTING A TV AND DVD PLAYER. AFTER CONFERRING WITH THE PARTIES,
THE COURT PROVIDES A WRITTEN RESPONSE ASKING THE JURY WHICH EXHIBIT(S) THE
JURY WISHES TO VIEW. THE JURY SUBMITS A SECOND NOTE INDICATING IT WISHES
