



| <p style="text-align: center;"><b>ORDER AMENDING APRIL 19, 2013 ORDER REGARDING<br/>         DEFENDANT'S MOTION FOR AN EXTENSION OF TIME (D-35(A))</b></p> |   |

On April 19, 2013, the Court issued an Order granting in part and denying in part the defendant's motion for a one-week extension of time to respond to the Order issued by the Court on April 16, 2013 (C-33). The April 19 Order extended the deadline to respond to Order C-33, but only by two days. Minutes after issuing the April 19 Order, the Court received the People's response indicating that they did not object to the defendant's motion. The Court stands by the comments it made in the April 19 Order. However, in all candor, it acknowledges that if the defendant's motion had been filed as unopposed, the Court would have granted it. Accordingly, in the interest of fairness, the Court amends the April 19 Order to extend the deadline to respond to Order C-33 by one week, from April 22 until

April 29. Both parties shall have until Monday, April 29, to respond to that Order. This situation should illustrate for each party the usefulness of conferring with the opposing party before most motions or requests are filed, even if such conferral is not necessarily required by section A(1) of the Court's April 16, 2013 Supplemental Case Management Order (C-32).


