**Please do not come to court if:**

1) you have been diagnosed with COVID-19 (“Novel Coronavirus”) and you have not received a subsequent test confirming that you are currently virus-free; (2) you have been in direct contact with someone who has been diagnosed with COVID-19 within the past fourteen days and are not fully vaccinated (3) you are experiencing a fever, cough, shortness of breath, recent loss of smell or taste or any other respiratory illness symptoms.
