**AMENDED ORDER REGARDING THE MEMBERSHIP AND DUTIES OF THE
COMMUNITY ADVISORY BOARD, OTHERWISE KNOWN AS PRETRIAL SERVICES
ADVISORY BOARD, FOR THE NINETEENTH JUDICIAL DISTRICT**

WHEREAS, C.R.S. § 16-4-105 authorizes the use of a Pretrial Services program to assist the Court in determining bail and type of bond by gathering and verifying information about defendants prior to the release of these individuals; and

WHEREAS, pursuant to C.R.S. §16-4-105(3)(b), a Pretrial Services program was originally established pursuant to a plan formulated by a Community Advisory Board (otherwise known as Pretrial Services Advisory Board) for such purpose and appointed by the Chief Judge of the 19th Judicial District; and

WHEREAS, the Pretrial Services program was previously under the oversight of the Weld County Sheriff and through resolution of the Board of Commissioners of Weld County, was transferred to the Pretrial Services Unit of the Weld County Justices Services Division; and

WHEREAS, current membership of the Pretrial Services Advisory Board has lapsed; and


WHEREAS, the Court desires that the Pretrial Services Advisory Board provide advisory assistance, through established bylaws and general administrative guidelines, toward establishing and enforcing standards for the operation of the Pretrial Services Program.

The Court hereby orders that the following representatives serve as members, or through their specific designee, of the Pretrial Services Advisory Board for the Pretrial Services Program under the Weld County Justices Services Division:

- a. The Chief Judge and/or Presiding Judge of the Criminal Court Divisions for the Nineteenth Judicial District or designee.
- b. The District Attorney for the Nineteenth Judicial District of the State of Colorado or designee.
- c. The Chief Probation Officer for the Nineteenth Judicial District or designee.

- d. The Chief Public Defender for Greeley Regional Office of the Public Defender or designee.
- e. The Weld County Sheriff or designee.
- f. The Nineteenth Judicial District Administrator or designee.
- g. The Clerk of the Combined Courts of the Nineteenth Judicial District or designee.
- h. A Weld County Commissioner,
- i. A Citizen Member at Large, who shall be a resident of Weld County at all times while serving in this capacity.
