ORDER CONCERNING ARRAIGNMENTS AND FIRST HEARINGS IN 2016	

IT IS ORDERED:

1. Law enforcement officers shall not issue a Summons and Complaint, or a Penalty Assessment with an arraignment or first appearance date on the following dates during the year 2016:

Monday, January 18	Martin Luther King, Jr. Day	Monday, September 12	Judicial Conference
Monday, February 15	President's Day	Tuesday, September 13	Judicial Conference
Monday, May 30	Memorial Day	Monday, October 10	Columbus Day
Monday, July 4	Independence Day	Thursday, November 24	Thanksgiving Day
Monday, September 5	Labor Day	Monday, December 26	Christmas Day

2. All Penalty Assessments containing *Traffic Infractions ONLY (TIA or TIB)*, issued by ALL law enforcement agencies, shall set First Hearings on: **Monday @ 9:00am**
3. Arraignments for Summonses and Penalty Assessments which contain charges **OTHER** than Traffic Infractions only, shall be set on the day and time as follows:

All law enforcement agencies EXCEPT <i>Colorado State Patrol, Weld County Sheriff and Greeley Police Department</i>		Monday @ 1:00pm
Colorado State Patrol and Weld County Sheriff	Defendant's last name beginning A - L	Tuesday @ 9:00am
	Defendant's last name beginning M - Z	Tuesday @ 1:00pm
Greeley Police Department	All citations	Thursday @ 9:00am

4. In regard to citations alleging violation of any of the 42-4-1301 alcohol offenses, the Court requests that all reasonable efforts be made to make those summons returnable at least twenty one (21) days but no more than forty two (42) days from the date of offense, using the chart above for correct day and time.
5. All Summons only citations shall be returnable at the Weld County Court, located at 915 10th Street, Greeley, CO.
6. All Penalty Assessment notices shall be made returnable at the Weld County Court, same address.
