**ORDER CONCERNING ARRAIGNMENTS AND FIRST HEARINGS IN 2019**

**IT IS ORDERED:**

1. Law enforcement officers shall not issue a Summons and Complaint, or a Penalty Assessment with an arraignment or first appearance date on the following dates during the year 2019:

<b>Tuesday, January 1</b>	New Year's Day	<b>Monday, September 9</b>	Judicial Conference
<b>Monday, January 21</b>	Martin Luther King Day	<b>Tuesday, September 10</b>	Judicial Conference
<b>Monday, February 18</b>	President's Day	<b>Monday, October 14</b>	Columbus Day
<b>Monday, May 27</b>	Memorial Day	<b>Monday, November 11</b>	Veteran's Day
<b>Thursday, July 4</b>	Independence Day	<b>Thursday, November 28</b>	Thanksgiving Day,
<b>Monday, September 2</b>	Labor Day	<b>Wednesday, December 25</b>	Christmas Day

2. All Penalty Assessments containing *Traffic Infractions ONLY (TIA or TIB)*, issued by ALL law enforcement agencies, except Weld County Sheriff, shall set First Hearings on: **Monday @ 8:30 am**  
 All Weld County Sheriff penalty assessments and/or model traffic code violations shall set First Hearings on: **Tuesdays @ 8:30 am**
3. Arraignments for Summonses and Penalty Assessments which contain charges **OTHER** than Traffic Infractions only, shall be set on the day and time as follows:

<b>All law enforcement agencies EXCEPT</b> <i>Colorado State Patrol, Weld County Sheriff and Greeley Police Department</i>		Monday @ 1:00 pm
<b>Colorado State Patrol and Weld County Sheriff</b>	Defendant's last name beginning A L	Tuesday @ 8:30 am
	Defendant's last name beginning M Z	Tuesday @ 1:00 pm
<b>Greeley Police Department</b>	All citations	Thursday @ 8:30 am

4. In regard to citations alleging violation of any of the 42-4-1301 alcohol offenses, the Court requests that all reasonable efforts be made to make those summons returnable at least twenty one (21) days but no more than forty two (42) days from the date of offense, using the chart above for correct day and time.
5. All Summons only citations shall be returnable at the Weld County Court, located at 915 10<sup>th</sup> Street, Greeley, CO.
6. All Penalty Assessment notices shall be made returnable at the Weld County Court, same address.
