Stipulation Regarding Court Ordered Second Competency Evaluation	

On October 13, 2021, the Court issued an order granting the People’s request for a second competency evaluation of Ahmad Al Aliwi Alissa (the “Defendant”). The Court further ordered that the parties confer and submit a list of four agreed upon evaluators to the Court on or before October 20, 2021 and that the Court would then appoint an evaluator from the submitted list.

Subsequent to the Court’s October 13, 2021 order, the parties have conferred and agree that Dr. Patricia Westmoreland should be appointed by the Court to conduct the Court ordered second competency evaluation of Defendant. Dr. Westmoreland has confirmed she is available to complete a competency evaluation of Defendant and will be able to file a report including her findings within 35 days of appointment by this Court. Dr. Westmoreland’s curriculum vitae is attached as an exhibit to this stipulation.¹

¹ Dr. Westmoreland will be providing the parties with an updated curriculum vitae in short order. The updated curriculum vitae will be uploaded as Exhibit 2 to this stipulation as soon as possible.

WHEREFORE, the parties stipulate that Dr. Westmoreland should be appointed by this Court to conduct the Court ordered second competency evaluation of Defendant.
