



**TWENTY-FIRST JUDICIAL DISTRICT
ORDER OF THE CHIEF JUDGE APPROVING JURY TRIALS
PURSUANT TO ADMINISTRATIVE ORDER 2021-05**

Given the [Jury Trial Plan](#) that was approved by Mesa County Public Health on April 19, 2021, our district and county courts will now be able to proceed with multiple district and county court jury trials being conducted at the same time. The maximum number of jury trials that may proceed, however, is limited by the number of jurors who can assemble in the Jury Assembly Room at the same time (currently up to 60) but jury panels can also be assembled at staggered times during the day.

The trials listed below are trials that have currently been submitted for consideration and have been approved to proceed. Other trials that are scheduled during the times listed but have not been approved may subsequently be approved and added to the list at a later time.

Having reviewed the judges' requests presented at an *en banc* meeting held this afternoon, I find it appropriate to and do hereby approve the judges' requests to conduct jury trials as follows:
