Según la directiva 06-03 del presidente del tribunal, los intérpretes deben figurar en la lista de intérpretes autorizados por el Departamento Judicial de Colorado a fin de poder proveer servicios de interpretación en los tribunales.*

Interpreter Service are available – if you need an interpreter, inform the court prior to your hearing to ensure that an interpreter is present at all court appearance. A court-appointed interpreter will be scheduled to assist you **at no charge**. Call (970) 328-8563 to request an interpreter, at least one week prior to your court appearance.
