<p>Supplemental Information Concerning Proposed Initiatives 2013–2014 #85, #86, and #87 (Unofficially Captioned “Oil and Gas Operations”)</p>	

Petitioners/Cross-Respondents Mizraim Cordero and Scott Prestidge (“Petitioners”) respectfully supplement their briefs with new information that Respondents/Cross-Petitioners Caitlin Leahy and Gregory Diamond (“Proponents”) have sought and received approval from the Secretary of State to circulate signature petitions on Proposed Initiatives 2013–2014 #85, #86, #87, and #88 (“Proposed Initiatives”)¹ and are collecting signatures on Proposed Initiatives #85 and #88² despite their representations to both the Title Board and this Court that they would select only one of the Proposed Initiatives for circulation. *See* Proponents’ Op. Br., p. 11.

Petitioners request that the Court incorporate this new information into its consideration of whether the Title Board violated section 1-40-106(3)(b), C.R.S., by setting conflicting titles on the Proposed Initiatives based on Proponents’ assurances that they would not seek permission to gather signatures on more than

one of the Proposed Initiatives.³ As explained by the Title Board, its practice with respect to setting title on multiple similar initiatives is not grounded in article 40 but rather in its “belief” that there are “built-in incentives in the system” that discourage the proponents of multiple similar initiatives from “incur[ring] the additional cost of obtaining signatures” for more than one initiative. Title Board’s Op. Br., p 21. While such incentives may influence the behavior of proponents who lack significant financial resources, campaign finance reports filed with the Secretary of State reveal that there has been at least \$1.45 million in support of these Proposed Initiatives. *See* Exhibit G.⁴

The primary purpose of article 40 “is to make the initiative process fair and impartial.” *In re Title, Ballot Title, Submission Clause, and Summary for 1999–2000 Nos. 245(f) and 45(g)*, 1 P.3d 739, 742 (Colo. 2000). In contrast to the aims of article 40, the Title Board’s current process for determining whether one title

conflicts with another is uncertain and unfair. The Proponents represented to the Title Board that Proposed Initiatives #85, #86, #87, and #88 are a “packet” of initiatives for which “at most only one will be submitted” for signatures. Exhibit C 3:2–11, 23–24.⁵ In their briefs filed with this Court, Proponents likewise represented that the Proposed Initiatives are “alternative, and conflicting” and that “Proponents will only circulate” one of them because it would be “irrational” and “despite their assurances” to do so. Proponents’ Op. Br., p. 11 & Proponents’ Ans. Br., p. 10. Nevertheless, Proponents are now collecting signatures on two of the Proposed Initiatives and have approval to collect signatures on all four of them.

How the Title Board should apply section 1-40-106(3)(b)’s prohibition on conflicting titles to multiple similar initiatives advanced simultaneously by the same proponents has never before been decided.⁶ This is an issue of first impression that requires clarity, and this is an appropriate case for the Court to decide the issue. *See* Petitioners’ Op. Br., pp. 17–20 & Petitioners’ Ans. Br.,

There, however, the Court refused to consider the issue because the initiatives were not simultaneously brought and the first initiative had been abandoned by the proponents. *Id.* at 870.

pp. 19–21. Proponents are capitalizing on the vagueness of the law to their advantage by playing a shell game. Only Proponents know their political strategy, so there is no telling how long Petitioners will be kept in the position of guessing which of the Proposed Initiatives will be placed on the ballot and until then Petitioners will be forced to continue to expend time and resources fighting all of the Proposed Initiatives.

Proponents succeeded in receiving titles for their Proposed Initiatives based on their representations at the outset of the Title Board’s April 3 hearing that they would seek to gather signatures on no more than one of the Proposed Initiatives, representations for which there is no clear mechanism for challenge because the Title Board cannot meet again until December 3, 2014. *See* § 1-40-106(1). Now that they have their titles, Proponents are betting that even if Petitioners locate a venue to challenge Proponents’ representations, that challenge will be rejected.

For these reasons, Petitioners respectfully request that the Court consider this new information, hold that the Title Board violated section 1-40-106(3)(b) by using a process for determining conflicting titles that is inconsistent with both the statute’s language and the intent of article 40 to ensure that the citizen initiative process is fair and impartial, remand the Proposed Initiatives to the Title Board for determinations on conflicting title consistent with this Court’s instructions, and

order that Proponents are barred from collecting signatures on more than one of the Proposed Initiatives.

Signature drive for local control oil and gas initiatives start in Colorado

The drive for signatures to put three initiatives bolstering local control of oil and gas drilling on the November ballot started Wednesday morning, organizers said.

"We still have no legislation solution and absent that, we have to go to the ballot," said Nick Passanante, director of the ballot campaign committee Coloradans for Safe and Clean Energy.

Petitions are being circulated for Initiative 89, [the so-called Environmental Bill of Rights](#), as well as Initiatives 85, which would set the distance drilling rigs must be from homes at 1,500 feet and 88, which would establish a 2,000-foot setback. The existing state requirement is 500 feet.

All proposed measures three are backed by U.S. Rep. Jared Polis, D-Boulder

A Polis-affiliated issues committee has contributed \$1.45 million to the ballot initiative campaign.

[Gov. John Hickenlooper has been trying to broker compromise legislation](#) that would give local governments more control but also guarantees the ability of oil and gas companies to operate.

Polis has said that if a suitable bill can be developed and passed during a special legislative session, he would withdraw his support for the measures.

"As of last night there no legislation and we can't wait," Passanante said. "We have to collect nearly 87,000 signatures by August 4th."

There were about 60 people out collecting signatures in Denver Wednesday morning, Passanante said, and offices have been opened in Denver, Cherry Creek and Aurora.

Passanate said there eventually will be six to eight offices in the Denver-Fort Collins area, and two in both southern Colorado and the Western Slope.

A total of \$1.3 million has already been committed to TV advertising for the fall, Passanante said.

Title language for Initiative 88 was approved by the state Supreme Court last week. Passanante said 85 and 89 still are awaiting approval.

"We are gathering signatures ahead of the Supreme Court ruling, presuming they will be approved," he said. "If there are changes, we will adjust accordingly."

There are nine Polis-backed measures. Backers have said they would select one local-control and one setback initiative for the fall ballot.
