Kevin Neal Patterson II and Eric Leveridge (“Petitioners”) and Respondent Denise Burgess (“Respondent”), pursuant to C.A.R. 42, submit this Stipulated Motion for Dismissal relating to the consolidated appeals in this matter, and in connection therewith do state:

1. Petitioners are the designated representatives for Initiatives 2017-2018 #162 and #166 (“Initiatives”), and the Court consolidated the appeals they took from the decisions of the Title Board.

2. By letter to the Secretary of State, Petitioners have withdrawn the Initiatives, which they are authorized to do by statute. C.R.S. §1-40-134.

3. As such, Petitioner and Respondents agree that this appeal should be dismissed, pursuant to C.A.R. 42, as there is no remaining dispute over the actions of the Title Board.

4. With such dismissal, Petitioners and Respondents will each bear their own attorney's fees and costs incurred in connection with this appeal.
