Background of the Colorado Child Protection Ombudsman Board

Pursuant to § 19-3.3-102(1), C.R.S. (2015), on or before January 1, 2016, the General Assembly established the Independent Office of the Child Protection Ombudsman, an independent agency housed within the Colorado Judicial Department. As part of this newly created office, the legislation also established an independent, nonpartisan Child Protection Ombudsman Board (“Board”) consisting of at least 12 members based on appointments made by the Chief Justice of the Supreme Court, the Governor, the President and Minority Leader of the Senate, and the Speaker and Minority Leader of the House of Representatives. §§ 19-3.3-102(2)(a), (b), C.R.S.

The Board’s membership was required to be appointed by August 31, 2015. § 19-3.3-102(2)(b), C.R.S. (2015). The current members of the Board are as follows:
